Information and request of the consent to the processing of personal data D. Lgs. N. 196/2003 and Art.13 of the EU Regulation 679/2016

In accordance with Article 13 of the Code that regards the protection of personal data (D. Lgs. N. 196/2003 and of the EU Regulation n. 2016/679 ("GDPR 2016/679")), laying down rules for the protection of people and other entities regarding personal data processing, we wish to inform You that the personal data which you provide will be object of the processing in compliance with the rule mentioned above.

1. Holder and responsible of the processing

With regard to the personal data processed by the Company, we inform You that the "Holder" of the processing is:

Personal data will also be processed for the purposes above mentioned by the employees of the Company specifically named as responsible of the processing. The updated list of all the External Responsible and those specifically appointed by the Company is available at the headquarters of the Company, contacting the Holder at the addresses mentioned below.

2. Purposes and methods of the processing of personal data

The personal data of the interested party are processed in the context of the normal activity of the Holder, for the prosecution of the following activities:

- 1. Correct and complete execution of the obligations of the contractual relationship;
- 2. Administrative and accounting fulfillments that are strictly connected to the contract;
- 3. Fulfillment of specific obligations required by law, laid down in a Regulation or under Community legislation (for example, those which rely on anti-money-laundering);
- 4. Commercial activities and distribution of newsletters.

The processing of personal data takes place under the authority of the Holder, by persons specifically charged, authorized and instructed on the processing in accordance with the privacy Regulation through manual, IT or telematics instruments, with logics that are strictly related to the purposes and, anyway, in order to guarantee the privacy and the safety of the personal data.

Processing of personal data may also take place, on behalf of the Holder, by the Responsible of the processing specifically designated in accordance with Article 28 of the Privacy Regulation.

The personal data will be reserved for a period determined on the basis of criteria which are founded on the nature and on the duration of the contract and on the protection needs of the interests of the interested party.

3. Legal basis of the processing, nature of the conferment and consequences of an eventual denial, consent of the interested party

With reference to the purposes provided in the preceding paragraph 2, point 1, 2 and 3 (Article 6, paragraph 1, letter B), the conferment of personal data is obligatory and constitutes a necessary requirement for the execution of the Contract. As a matter of fact, the missed conferment determines the impossibility of receiving the services which are subject of the Contract and, therefore, the legal basis of the related processing is the correct execution and management of the Contract. Regarding the point related to commercial activities and newsletter sending, the legal basis is represented by Your specific and optional consent (Article 6, paragraph 1, letter A).

4. Communication and diffusion context

The collected data will not be spreaded and will not be reportable without Your explicit consent, except the necessary communications which may cause the transfer of data to public authorities, consultants, collaborators or other entities for the fulfillment of the legal obligations.

5. Personal data transfer

If necessary for the execution of the contract, the personal data of the interested party may be transferred to EU and/or non-EU countries, with full respect of the Privacy Code, the Privacy Regulation, the measures and decisions of the Data Protection Authority, as well as the Community Legislation. In particular, the Holder is committed to respect the provisions provided, respectively, by the decisions 2001/497/EC, 2004/915/EC and 2010/87/EU (depending on the case), which impose the signing of "standard contractual clauses" between parties involved in the extra EU data processing.

6. Rights of the interested party

Articles 15 and following of the Privacy Regulation confer to the interested party the right to obtain:

- The confirmation of the existence or less of the related personal data, even if they are still not registered, and their communication in an intelligible form;
- The indication of the origin of the personal data, the purposes and the methods of the processing, of the logic applied in case of processing made with the help of electronic instruments and of identification details of the Holder;
- The anonymous update, correction, integration, cancellation, transformation or the blocking of the processed data in violation of the law - including the ones which do not need the conservation in relation to the purposes for whom the data are collected or subsequently processed;
- The statement that such operations have been brought to the knowledge, also as regards their content, of those to whom the data have been communicated or spreaded, except the case in which such fulfillment is impossible or implies a use of resources manifestly disproportionate compared to the protected right.

Moreover, the interested party has the right:

- To oppose, in whole or in part, for legitimate reasons, to the processing of the personal data concerning him, even if relevant to the purpose of the collection;
- To propose a complaint to the Data Protection Authority in the cases referred to the Privacy Regulation;
- To personal data portability within the limits laid down in Article 20 of the Privacy Regulation.

If our Company does not reply within the deadlines specified by the law or the answer to the exercise of the rights of the interested party is not suitable, it will be possible to propose a complaint to the Data Protection Authority. Where it is considered that our Company has committed a violation of the Privacy Code and/or of the Privacy Regulation, it will be possible to propose a complaint to the Data Protection Authority.
